New Aid Codes 7V and E8

Senate Bill (SB) 1569 (Chapter 672, Statutes of 2006), codified in Welfare & Institutions (W&I) Code Sections 13283, 14005.2, and 18945 created the Trafficking and Crime Victims Assistance Program (TCVAP). This program offers state-funded benefits for non-citizen victims of human tracking, domestic violence, and other serious crimes.

Effective immediately, a victim under the TCVAP can be eligible for full-scope Medi-Cal with a Share of Cost (SOC) using the new Aid Code 7V. Aid Code 7V has coverage for emergency services under Title XIX at 50 percent Federal Financial Participation (FFP); prenatal care under Title XXI (Children's Health Insurance Program) at 65 percent FFP; and all other services at 100 percent State General Fund (GF).

In addition, W&I Code sections 14011.7,14148.04, and 15832 (SEC. 137 of SB 184 (Chapter 47, Statutes of 2022) enacted the Newborn Gateway, which created the new Aid Code E8 for members eligible for full-scope Medi-Cal under the Accelerated Enrollment (AE) Medical Access Infant Program (MCAIP) Newborn Gateway Linked Infant with no SOC. Aid Code E8 will be effective July 1, 2024 and is funded through Title XXI at 65 percent FFP. Newborn Gateway Linked Infant-MCAIP

(Title XXI) provide full benefits with no SOC to newborns aged 0 up to 1 year, born to mothers enrolled in the Medi-Cal Access Program under aid code 0E in the month of the newborn's birth. Children in aid code E8 will not be terminated at one year of age but will be placed into a "Hold" status pending evaluation for MCAIP.

New aid code description is as follows:

Aid Code	Benefits	SOC	Program/Description
7∨	Full Scope	Yes	Trafficking and Crime Victims Assistance Program - covers non-citizen victims of human trafficking, domestic violence, and other serious crimes.
E8	Full Scope	No	Accelerated Enrollment Medical Access Infant Program Newborn Gateway Linked Infant
