Coming Soon: Medi-Cal Dental CDT-2025

Effective April 1, 2025, Medi-Cal Dental’s procedure codes are updating to align with the Current Dental Terminology (CDT) Codes for 2025. This update reflects the American Dental Association’s updated [CDT Codes](#).

The changes are in listed under the following three categories: Edited, Added, or Deleted Procedure Codes.
