Coming Soon: Fee-For-Service Billing for Federally Qualified Health Centers and Rural Health Clinics

Medi-Cal reimburses Federally Qualified Health Center (FQHC) and Rural Health Center (RHC) services at Prospective Payment System (PPS) per-visit rates, conditioned upon the availability of federal financial participation (Welfare & Institutions (W&I) Code section 14132.100). Per the enactment of Assembly Bill 116 (2025–2026 Regular Session), FQHCs and RHCs will be reimbursed Fee-For-Service (FFS) rates for members who do not qualify for federal full-scope starting July 1, 2026 dates of service.

For dental services, FQHCs and RHCs will need to comply with Medi-Cal Dental billing guidelines and claim submission processes to receive reimbursement for members who do not qualify for federal full-scope starting July 1, 2026.

All FQHCs and RHCs are invited to join free webinar sessions designed to help FQHCs and RHCs better understand what is required, how to bill, and when to bill Medi-Cal Dental FFS. The following topics will be covered:
